Change ceiling Tiles near the Main Office. Dr. Jaber would like support of the Superintendent and Board to receive the Sinking Funds these funds could be used to enhance the kitchen sizes at both Beacon and Tyrone Elementaries as well as help to remodel schools.

Tyrone Elementary received COGNIA Accreditation. Tyrone was rated the cleanest school in the district. The walls in the gym and lunchroom were painted forest green, and the floors were waxed. The fifth grade was the highest-performing grade in the district, as noted in the assessment. The specialized student services rooms were clean and spacious, and the teacher lounge was colorful, although it was awaiting some new furniture. Improvements: The following rooms need carpet removal by November or December of this year: rooms 103, 105, 106, 107, 108, 109, 110, 111, 112, 201, 202, 203, 204, 205, 206, and the main office. Dr. Jaber's goal is to have the Tyrone Elementary School walls painted by Spring 2026.

The last school to receive a walkthrough was the CCI the Harper Woods College & Career Institute. Improvements the staff is fully equipped the building is clean and one of the schools not affected by the fund cuts Five Container homes are ready to be used for the Excellence Institute received new threading machines. According to Dr. Jaber there were no concerns regarding the improvements regarding the CCI at this time.

district will have the opportunity to systematically traverse through that building with appropriate scheduling daily, as promised two years ago to the elderly of the City of Harper Woods program called the Senior Sneakers, will have the opportunity to work out from 6:00 am until 10:00 am, free of charge, and it falls under AARP. Students will be able to sign the pillars, which will be covered. Additionally, all of the school buildings in the district have the opportunity to place their message inside a time capsule that will be reopened in 2125, 100 years from now. There will also be a recording to give a description of the district as well as the Excellence Institute.
