Superintendent Steven McGhee addressed concerns presented to School Board during public participation. Nationwide teacher shortage, non-instructional staff shortage, Mr. McGhee informed the district that the class of 2020 had the largest rate of graduates in the history of Harper Woods. The class of 2021 had 190 in the graduating class, 3.4 million dollars in scholarships 1.2 million dollars was in athletic scholarships.12 students in the class of 2022 will graduate with a high school diploma, an associate degree and a Career Path Certification something that has never been done in the history of the United States. Superintendent McGhee also discussed Dual Enrollment and Meta Labs. Overcrowding has been addressed and enrollment is still open to all residents of the city of Harper Woods. 30% of enrollment was School of Choice 70% of enrollment was residents of Harper Woods. Harper Woods School District has paid off loans in the sum of 1.5 million dollars for teacher pensions in addition to Harper Woods teachers receiving 1.8 million dollars in raises.
